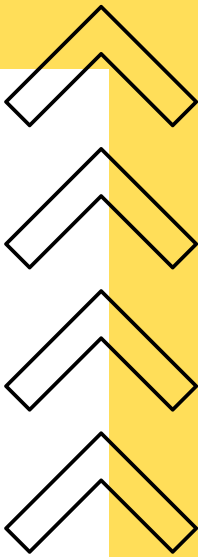


# EDUCATION REENVISIONED BOCES 2024 - 2025

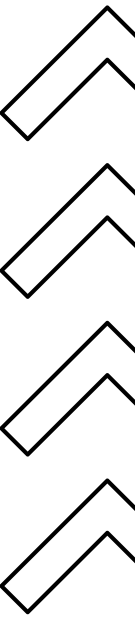

# EDUCATION REENVISIONED BOCES 2024 - 2025



## What is a homeschool enrichment program?

- A homeschool enrichment program is a part-time public program that provides non-religious enrichment courses to any student who is age-eligible to enroll. The operator of the homeschool enrichment program determines which courses will be offered. Families choose the enrichment program that meets their needs.
- Families who enroll their child in the homeschool enrichment program may choose additional non-public funded opportunities for their child(ren).
- Students are required to attend the public-funded program for 90 hours each semester they are enrolled.

- **How do parents enroll a child in a homeschool enrichment program?**
  - According to Colorado law, parents or guardians must provide a written notification explaining their intent to homeschool their child. This notification must be submitted to any Colorado public school district office at least 14 days before establishing the homeschool program. The notification should include the child's name, age, place of residence, and attendance hours. Additionally, the written notification must be resubmitted annually for each year the homeschool program is maintained after the initial year.
  - Once the requirement for notification is complete, the parent may choose to enroll a child in one publicly funded program. Parents should work with the specific program provider to determine the process of enrollment.
  - Parents who choose to complete the notification process may enroll their child in a homeschool enrichment program and may enroll their child in other fee-based programs. Each student may only enroll in one publicly funded program.

### **What subjects are required to be taught in a homeschool enrichment program in Colorado?**

- The selection of curriculum is at the discretion of the program provider. Education reEnvisioned BOCES serves as the authorizer of the program and ensures the program meets the part-time public funding requirements.
- Instruction during the homeschool enrichment program must be non-religious.
- Students enrolled in a homeschool enrichment program are not required to participate in state testing or meet other public school requirements.

### **What are the attendance requirements for homeschool programs in Colorado?**

- Homeschool enrichment programs in Colorado are considered part-time funded programs. To meet the funding requirements, homeschool enrichment programs must provide 90 hours (or more) of instruction each semester. The Education reEnvisioned BOCES requires contracted providers to maintain an average attendance rate of at least 90%.
